**Distribution policy & priority:** *As of January, 2010 repository material will no longer be distributed to small growers. Material will only be distributed, in order of priority, to:*

1. Canadian nurseries registered with the Canadian Grapevine Export Program
2. Other Canadian nurseries
3. Canadian research breeders and evaluators
4. Canadian commercial vineyards and Canadian grape grower associations
5. Foreign commercial nurseries, research breeders and evaluators.

Individuals or non-commercial growers wishing to obtain material from the Centre for Plant Health (CPH) should submit consolidated orders through Canadian grape grower associations.

**Type and quantity of material distributed:** The CPH usually maintains two potted mother plants of each variety and therefore very limited quantities are available for distribution. Every effort will be made to fill requests, however, if a variety/rootstock is in high demand, the above priority policy will be strictly followed. Cuttings will measure approximately 25 to 37.5 cm. (10 to 15 inches) in length and contain at least 2 buds with a caliper of approximately 6 to 12.5 mm (1/4 to 1/2 inch). Requests for rooted plants will be considered on a case by case basis. Please contact the CPH for further information.

**Ordering deadline:** February 28. Late requests may not be accepted.

**Prices for dormant wood cuttings:**

- Canadian customers: \$2.50 cutting plus GST
- Foreign customers: \$5.00 (Canadian) per cutting plus GST.

An invoice for cuttings received will be mailed out after orders have been filled and delivered.

**Shipping and Handling:** All costs associated with shipping and handling are the responsibility of the person placing the order. COD courier shipping is not available. The CPH is unable to invoice for shipping and handling. Indicate one of the following options for payment with your order. Accepted shipping methods are:

- Courier providing either **an account number** or **a credit card number** for use by the CPH is provided. You will be contacted directly by CPH staff for a credit card number when the plant material is ready to ship if this was not provided with your order. This information will be kept strictly confidential.
- COD delivery via Greyhound bus (Canadian growers only)
- Personal pickup

**Virus Tested Status:** The repository accessions have been tested using internationally accepted methods. Unless otherwise indicated, all material leaving the CPH is apparently free from viruses and other diseases detectable by the tests used at the CPH. Most of the material from the repository is eligible for export to the United States, Australia, New Zealand and other countries. The "Comments" column on the available list identifies accessions that are infected with either of two viruses allowed under the CFIA export certification program. Her Majesty the Queen in right of Canada, Her officers, servants and employees, and the Centre for Plant Health cannot be held responsible for virus freedom of any variety or selection of plant material supplied by the Centre.

Although many of the mother plants have been examined for trueness-to-type, identification of some of the foreign material is extremely difficult. Her Majesty the Queen in right of Canada, Her officers, servants and employees and the Centre for Plant Health assume no responsibility for and do not guarantee the identity of each variety, selection or rootstock supplied by the Station, and cannot be held responsible for variety trueness and performance of any such plant material so supplied or obtained. Material received from us should be examined closely for identification discrepancies. We appreciate receiving results of varietal observations to upgrade our information.

**Proprietary Accessions:** If an owner is listed next to an accession, propagative material from that accession cannot be released without the owner's permission. Please contact the owner and ask that person to forward their permission in writing (mail, fax, E-Mail) to the CPH. The owner's addresses and contact information are listed on the last page. Accessions with A. Schmidt as the owner can only be shipped to Canadian growers.

**How to Order:** Requests are to be submitted in writing by mail, e-mail or fax no later than February 28 and preferably using the form provided by the CPH with the following information:

- Variety or rootstock name with the associated Q number and the number of cuttings desired for each request.
- Full mailing address and telephone number, and e-mail and fax, if available. A street number must be provided if the method of delivery is courier.
- Shipping information.
- Foreign requests only: An import permit is to be provided where applicable. The CPH is obligated to meet a foreign country's import requirements. Enquire with regulatory agencies in your country for import requirements. Material will not be shipped without proper permit documentation and if import requirements cannot be met.

**NOTE:** It is the requester's responsibility to provide the required information when ordering material. The CPH may be unable to send material if the information provided is inadequate or incorrect.

**RSP & Fleck:** indicates that the variety is infected with either grapevine rupestris stem pitting disease or *Grapevine rupestris stem pitting associated virus* (RSP) or grapevine fleck disease or *Grapevine fleck virus* (Fleck). Varieties infected with these viruses are eligible for certification under the CFIA grapevine export certification program but may not be eligible for export to some countries or certain U.S. states.
